

Dear Friends and Family,

Jillian Friedman of Cape Coral, Florida finds herself in need of a kidney transplant and desperately needs the help of her family, friends and the community to get her and her family through this most difficult time.

Jillian was born prematurely with a number of medical problems. Just recently it was discovered, that due to an undiagnosed genetic condition, she was in kidney failure. The serious side effects of the disease are debilitating to the point where Jillian's kidney function is getting less and less with each passing week. Her father, Daniel, has stepped forward to donate one of his kidneys to save Jillian's life. Daniel has been found to be a perfect match, and the transplant team is now making plans for the surgery. Jillian and Daniel are both under the care of doctors at the Jackson Memorial Hospital, in Miami Florida, where the transplant will take place.

Funding for this life-saving procedure is a monumental task, as there will be many uninsured, medically-related expenses not covered by insurance. Some of those costs include: co-payments for doctor appointments, medical supplies, travel and relocation expenses, and the costly immunosuppressant medications that Jillian will be on for the rest of her life. The Friedman family cannot meet this challenge alone.

To help ease this financial burden, a fundraising campaign in Jillian's honor has been established with the National Transplant Assistance Fund (NTAF). NTAF is a nonprofit organization that has been assisting the transplant community with fundraising for 25 years. 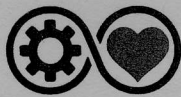
